

ORDINANCE NO. 1428-2012

AN ORDINANCE ESTABLISHING WATER CONNECTION CHARGES

WHEREAS, the City of Angola ("City") has heretofore constructed and has in operation a waterworks facility for the purpose of treating and supplying water;

WHEREAS, the municipal legislative body shall, by ordinance, establish just and equitable fees for the services rendered by the waterworks;

NOW, THEREFORE, be it ordained by the Common Council of the City of Angola, Steuben County, Indiana:

Section 1. Connection charge.

That there be established for the connection of all new customers seeking service of the waterworks system in the City, the following connection charge and that the City of Angola, Indiana Code of Ordinances, Title V, Chapter 51, is hereby amended by the addition of the following:

CONNECTION CHARGE

(A) *New connections.* The connection charge shall be collected from each new customer prior to connection to the waterworks system. Each new connection shall pay a connection charge in an amount determined by the following schedule:

(B) *Authorization to waive charge.* The Board of Public Works and Safety is authorized and empowered, in specific instances for such areas as cemeteries, golf courses, and parks, to waive, modify or defer in whole or in part the connection charge.

(C) *Receipt of connection charge.* The connection charge shall be receipted to the Water Improvement Fund and used for additions, improvements, and extensions.

(D) *Remonstrance restriction.* Any and all owners of real estate, persons or corporation, their or its survivors, heirs or assigns, who shall connect to the waterworks system, pursuant to the subchapter, shall agree in writing prior to the connection to waive their rights to remonstrate against annexation by the City.

Section 2. Conflicting provisions.

All provisions of the City of Angola, Indiana Code of Ordinances, Table of Special Ordinances, Table VII: Water and Sewer Main Construction shall remain in full force and effect and shall co-exist with this ordinance. New customers seeking service

shall be charged the greater of said charges or fees. In addition, this ordinance is exclusive of any private water and sewer line construction agreements.

Section 3. Effective date.

That this ordinance shall be in full force and effect January 1, 2013 from and after its passage and execution by the Mayor. Passed and adopted by the Common Council of the City of Angola, Indiana, and by me approved this 17th day of December 2012.
