

January 17, 2022

The regular meeting of the Common Council of the City of Angola, Indiana was called to order at 7:00 p.m. at City Hall, 210 North Public Square with Mayor Richard M. Hickman presiding. Council Members Gary L. Crum, David A. Olson, and Jerold D. McDermid answered roll call. Council Members Kathleen G. Armstrong and David B. Martin were absent. Clerk-Treasurer Ryan P. Herbert recorded the minutes.

Among those present were City Attorney Kim Shoup, Chief of Police Ken Whitmire, Human Resources Administrator Sue Essman, City Engineer Amanda Cope, Water Superintendent Tom Selman, and Engineering Assistant Nick Gerber.

Also, among those present was Kristie Trick, Marvin Baker, and Karen Snell.

APPROVAL OF THE MINUTES

Council Member Olson moved to approve the January 3, 2021 minutes. Council Member Crum seconded the motion. The motion carried 3-0.

Minutes of the November 1, 2021 Board of Public Works and Safety meeting were presented for Council information.

UNFINISHED BUSINESS

No action was taken on Ordinance No. 1689-2022, AN ORDINANCE AMENDING THE ANGOLA MUNICIPAL CODE, TITLE 18 UNIFIED DEVELOPMENT ORDINANCE, CHAPTER 18.16 ZONING MAP. (Amending Zoning Map from Agricultural District (AG) to Planned Development District (PD)), due to lack of voting quorum. Three Council members were present, of which Council Member McDermid had to recuse himself from voting due to prior knowledge of the matter.

Ordinance No. 1690-2022, AN ORDINANCE AMENDING THE ANGOLA MUNICIPAL CODE TITLE 10 VEHICLE AND TRAFFIC, CHAPTER 10.25 PARKING, was read by title and presented to Council on third and final reading. Council Member Olson moved to approve. Council Member Crum seconded the motion. The motion to approve on third and final reading carried 3-0. (new number 1689-2022)

NEW BUSINESS

Ordinance No. 1691-2022, ADDITIONAL APPROPRIATION ORDINANCE FOR THE CITY OF ANGOLA, INDIANA COVID CDBG OCRA RESPONSE PROGRAM PHASE 3 FUND, was read by title and presented to Council on first reading. Council Member Crum moved to approve. Council member McDermid seconded the motion. The motion carried 3-0.

Kristie Trick from Freedom Academy Community Outreach Thanked th City of Angola for their ongoing support and partnership through the use of the Angola Training Center. In 2021 59 students and 8 companies were served. This was the eight year of the partnership. Freedom Academy has invested in bringing industry 4.0 to the region and adding two robots to the Angola Training Center for advanced training in automation and robotics. Freedom Academy plans to bring the Medical Assistant program to the center in 2022.

Council Member McDermid moved to approve the Façade Grant agreement with Snell Property investments LLC? Karen Snell for property located at 20 N Public Square in the amount of \$5,000. Council Member Crum seconded the motion. The motion carried 3-0.

Council Member McDermid moved to approve the Façade Grant agreement with Marvin T. Baker, BLBG LLC for property located at 114 N. Elizabeth St. in the amount of \$5,000. Council Member Olson seconded the motion. The motion carried 3-0.

Council Member Olson moved to approve the List of Outstanding Warrants Declared Cancelled as of December 31, 2021, outstanding and unpaid from 2019 for \$2,210.55. Council Member Crum seconded the motion. The motion carried 3-0.

The Clerk-Treasurer's Depository Statement and Cash Reconciliation for the month ending December 2021 was presented for Council information.

OTHER NEW BUSINESS

Council Member Olson stated that he had received reports of issues with darkness at the intersection of Williams and Mechanic Streets, and requested the Street, Alleys, and Lighting committee investigate.



APPROVAL OF ACCOUNTS PAYABLE VOUCHERS


