The regular meeting of the Common Council of the City of Angola, Indiana was called to order at 7:00 p.m. at City Hall, 210 North Public Square with Mayor Richard M. Hickman presiding. Council Members Gary L. Crum, Kathleen G. Armstrong, David B. Martin, and Jerold D. McDermid answered roll. Council Member David A. Olson was absent. Clerk-Treasurer Ryan P. Herbert recorded the minutes.

Council Member Martin moved to approve. Council Member McDermid seconded the motion. The motion to approve carried 4 -0.

NEW BUSINESS

Ordinance No. 1718-2022. APPROPRIATION REDUCTION ORDINANCE FOR THE LOCAL ROAD AND BRIDGE MATCHING GRANT FUND, was read by title and presented to Council for first reading. Council Member Martin moved to approve. Council Member McDermid seconded the motion. The motion carried 4-0.

Sarah Funkhouser of the YMCA of Steuben County presented the request for contribution toward the Sheets Family Park expansion. Council Member Martin moved that The City contribute \$250,000 toward the project. Council Member Crum seconded the motion. The motion carried 4-0.

CLERK-TREASURER AND DEPARTMENT HEAD REPORTS


