### **MARCH 3, 2025**

The regular meeting of the Board of Public Works and Safety of the City of Angola, Indiana was called to order by Chair David B. Martin at 6:30 p.m. City Hall, 210 N Public Square. Members David B. Martin and David A. Olson answered roll call. Member Jerold D. McDermid was absent. Clerk-Treasurer Ryan P. Herbert recorded the minutes.

Among those present were City Engineer Amanda Cope, Fire Chief William Harter, Street Commissioner Chad Ritter, Water Superintendent Tom Selman, Wastewater Superintendent Jeff Gaff, Human Resources Director Sue Essman, and Police Patrol Officer Allie Curdes.

Also among those present were Council Members Randy Coffey and Charles Dowe, Jeff Klink, Don Wise, and Tom Filburn.

#### APPROVAL OF MINUTES

Member Olson moved to approve the February 3, 2025 minutes. Member Martin seconded the motion. The motion carried 2-0.

#### ORDER OF BUSINESS

Discussion was held regarding the request by Jeff Klink to place a gravel driveway through approximately 90 feet of City of Angola right-of-way at the end of Beverly Court to access his property. Mr. Klink would like to run a driveway to his barn on the property and would need to connect through the row-of-way to access Beverly Court. Also speaking was Don Wise who owns a portion of the property located at the end of the right-or-way that the driveway would need to run through. Mr. Wise stated that he was willing to allow the driveway to run through his property. Discussion followed. Member Martin said that the board had a similar request on Thomas Drive and allowed the property owner to place a driveway within the right-of-way as long as it was a hard surface. Further discussion followed. Member Martin moved to allow Mr. Klink to place a hard surface driveway through the city right-of-way to connect to. Member Olson seconded the motion. The motion carried 2-0.
