MAY 19, 2025

The special meeting of the Board of Public Works and Safety of the City of Angola, Indiana was called to order by Chair David B. Martin at 6:45 p.m. City Hall, 210 N Public Square. Members David B. Martin, David A. Olson, and Jerold D. McDermid answered roll call. No member was absent. Clerk-Treasurer Ryan P. Herbert recorded the minutes.

Among those present were City Attorney Kim Shoup, City Engineer Amanda Cope, Fire Chief William Harter, Deputy Clerk Stephanie Dean, and Police Patrol Officer Allie Curdes.

Also among those present were Cisco Otiz, Ken Wilson, and Council Members Randy Coffey, Jennfier Sharkey, and Charles Dowe.

APPROVAL OF MINUTES

Member McDermid moved to approve the March 3, 2025 minutes. Member Olson seconded the motion. The motion carried 3-0.

ORDER OF BUSINESS

Discussion was held regarding the request to waive additional utility connection fees for Wayne Street Commons located at 1030 S Wayne St. City Engineer Cope explained that when the project was originally the plan was for four one-inch water lines going into the two buildings. During construction builders ran into some constructability issues due to groundwater in the area and are proposing to change to one two-inch water line. The original connection fees paid for the one-inch lines were \$8,580.00 and the fee if they had originally planned one two-inch line would have been \$17,160.00. The property owner and builder are asking to waive the additional utility connection fees which are the difference between what was originally permitted and paid and the fees that would have been charged for the two-inch line. Member Olson moved to waive the additional utility connection fees for this project. Member McDermid seconded the motion. The motion carried 3-0.
