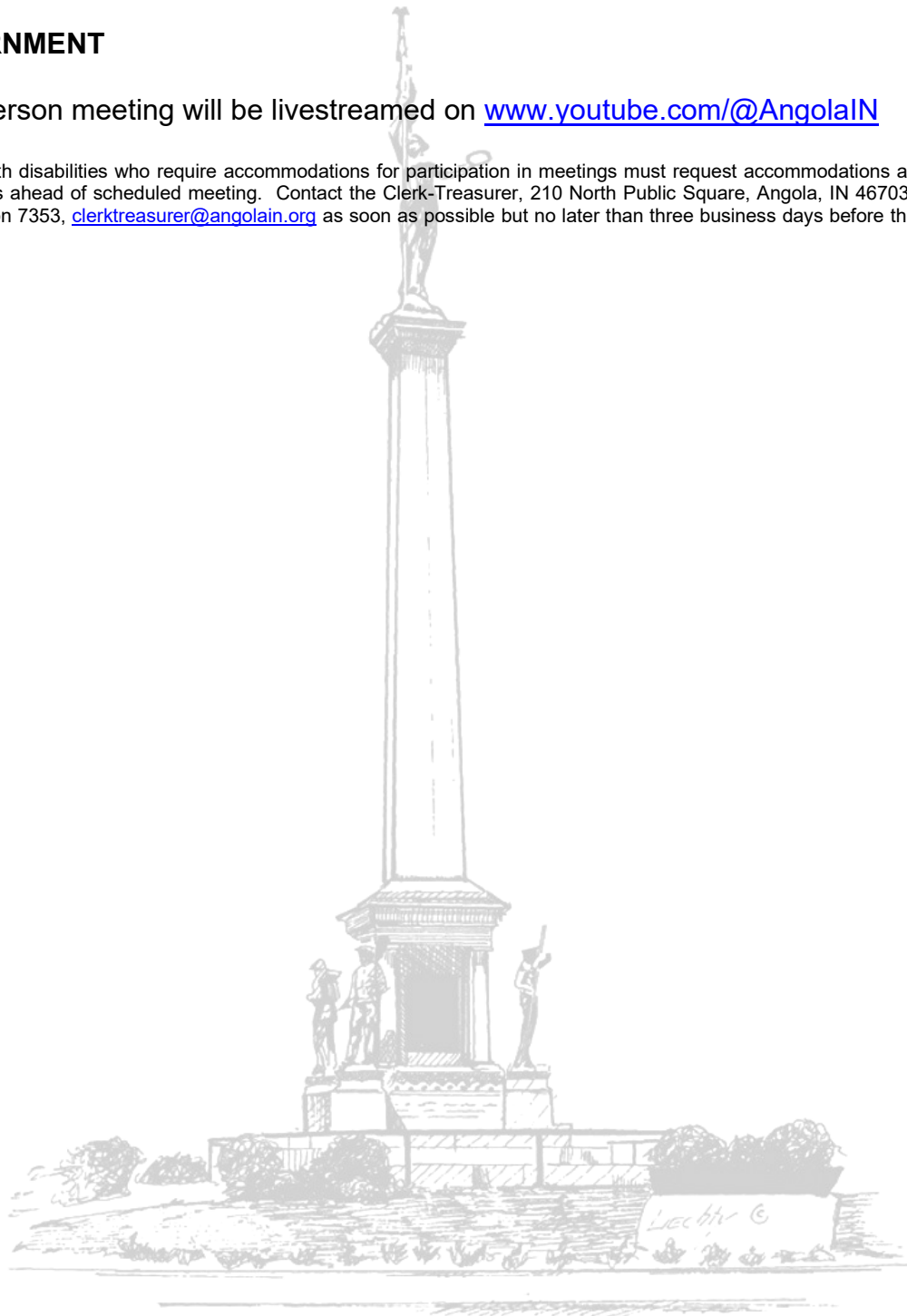

**January 20, 2026**

The regular meeting of the Common Council of the City of Angola, Indiana was called to order at 7:03 p.m. at City Hall, 210 North Public Square, with Mayor David B. Martin presiding. Council Members Randy Coffey, David A. Olson, Charles P. Dowe, and Jennifer L. Sharkey answered roll. Council Member Jerold D. McDermid was absent. Clerk-Treasurer Ryan P. Herbert recorded the minutes.

Among those present were City Attorney Kim Shoup, City Engineer Amanda Cope, Economic Development and Planning Director Retha Hicks, Police Chief Ken Whitmire, Fire Chief William Harter, Street Commissioner Chad Ritter, Park Superintendent Matt Hanna, and Engineering Assistant Nick Gerber.

APPROVAL OF THE MINUTES

Council Member Olson moved to approve the January 5, 2026 minutes. Council Member Coffey seconded the motion. The motion carried 4-0.

NEW BUSINESS

#### DEPARTMENT HEAD REPORTS

City Engineer Cope reported that the city section of the Pokagon project water main will be complete within three weeks at which time boring into the park will begin.

#### APPROVAL OF ACCOUNTS PAYABLE VOUCHERS

Council Member Dowe moved to approve the Allowance of Accounts Payable Vouchers 78026 through 78258, totaling \$1,637,448.81 which includes interfund transfers of \$267,335.00. Member Coffey seconded the motion. The motion carried 4-0.

**AN ORDINANCE AMENDING THE CITY OF ANGOLA, INDIANA CODE OF ORDINANCES ESTABLISHING FEES FOR SERVICES OF THE PLAN COMMISSION, THE BOARD OF ZONING APPEALS, THE HISTORIC PRESERVATION COMMISSION, AND ECONOMIC DEVELOPMENT & PLANNING DEPARTMENT**

BE IT HEREBY ORDAINED by the Common Council of the City of Angola, Indiana that Title 15 Buildings and Construction, Chapter 15.05 General Provisions is being amended by the text of existing provisions in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~:

Section 1. Subsection (D) of Section 15.05.050 Fees for services of the Plan Commission, the Board of Zoning Appeals, the Historic Preservation Commission, and the Economic Development and Planning Department is amended to read as follows:

(D) The following fees shall be charged for the services offered by the Economic Development & Planning Department:

(1) Improvement Location Permit \$25

a. ~~With Building Permit \$0~~

(2) Sign Permit \$25 per sign

This ordinance shall become effective following passage and adoption by the Common Council and approval by the Mayor.
