SEPTEMBER 8, 2020

The regular meeting of the Common Council of the City of Angola, Indiana was called to order at 7:00 p.m. at the Angola Training Center, 306 West Mill Street 1B, with Mayor Richard M. Hickman presiding. Council Members Gary L. Crum, David A. Olson, Kathleen G. Armstrong, David B. Martin, and Jerold D. McDermid answered roll call. No Council Member was absent. Clerk-Treasurer Debra A. Twitchell recorded the minutes.

Among those present were Chief of Police Stu Hamblen, City Attorney Kim Shoup, Street Commissioner Doug Anderson, City Engineer Amanda Cope, Wastewater Superintendent Craig Williams, Water Superintendent Tom Selman, Building Commissioner Scott Lehman, Park Superintendent Matt Hanna, Economic Development and Planning Director Vivian Likes, and Deputy Clerk Ryan Herbert.

Also, among those present were Ashlee Hoos of *The Herald Republican* and Colin Meadowcroft of WLKI.

REMARKS BY THE MAYOR

Mayor Hickman reported that the mural being painted on Craig Everage's building located on North Wayne Street was complete. The artist that painted the mural was from Rochester, New York. A sight is currently being selected downtown for another mural to be completed next spring.

Mayor Hickman then congratulated the Downtown Angola Coalition for receiving an OCRA Women's Legacy Grant. The Grant totals \$40,000 to be used to purchase a statue of Sojourner Truth that will be placed outside the Steuben County Court House.

Mayor Hickman also announced the City will receive a \$250,000 CDDG grant to provide small business relief loans. These loans will be administered through the Angola Investment Fund Board. He thanked June Julien with the Steuben County Tourism Bureau and the Angola Chamber of Commerce for their help with this process.

APPROVAL OF THE MINUTES

Council Member McDermid moved to approve the August 17, 2020 minutes. Council Member Olson seconded the motion. The motion carried 5-0.

UNFINISHED BUSINESS

Ordinance No. 1647-2020, AN ORDINANCE FIXING COMPENSATION OF ELECTED OFFICIALS OF THE CITY OF ANGOLA, INDIANA FOR THE YEAR 2021, was read by title and presented to Council on third and final reading. Council Member Olson moved to approve. Council Member Armstrong seconded the motion. The motion to approve on third and final reading carried 5-0. (Mayor and Clerk-Treasurer 2% increase)

Ordinance No. 1648-2020, AN ORDINANCE AMENDING THE ANGOLA MUNICIPAL CODE TITLE 10 VEHICLES AND TRAFIC, CHAPTER 10.25 PARKING, was read by title and presented to Council on second reading. Council Member Martin moved to approve. Council Member Crum seconded the motion. The motion to approve on second reading carried 5-0. (No parking Monument Plaza parking lot)

NEW BUSINESS

Wastewater Superintendent Williams opened and read aloud quotes for the Hires Lift Station Discharge Manhole Improvement Project. Engineer's cost estimate for the project totaled \$150,000.

Parrish Excavating \$229,605.00 \$19,836.00 \$249,441.00 erintendent Williams explained that this is a critical project with several challet

Superintendent Williams explained that this is a critical project with several challenges. There is a very tight timeframe for completion and contractors are all very busy. Three lift stations discharge into the manhole requiring repairs. The excavation would be 20' deep. Flow would have to be maintained by bypass pumping meaning the project needs to be completed before winter freezing temperatures. Discussion followed. Council Member Martin moved to award the bid to the sole bidder if they meet specs. Council Member Crum seconded the motion. The motion to award the bid if specs are met carried 5-0.

Member Olson seconded the motion. The motion to approve carried 5-0. (Spencer Pumper Tanker Fire Apparatus)

Mayor Hickman presented the 2021 Budget. A budget workshop was scheduled for Wednesday, September 16 at 5:00 p.m. at the Training Center.

Deputy Clerk Ryan Herbert presented the 2020 Budget Management Report which is presented annually in conjunction with the budget presentation. The report is historical, current, and projected revenues, expenditures, and cash balances for governmental funds over a period of eight years and may be used as a reference tool during the annual budget process. The report compiles information on operating, capital, and pension funds and includes the City's 2020 amended budget and 2021 proposed budget. An integral part of the report is the Notes and Assumptions section. Discussion followed.

Council Member Martin moved to approve the Addendum to Agreement with Pleasant Township compensating the City \$300,000 for a fire truck. Council Member Olson seconded the motion. Discussion followed. The motion to approve carried 5-0. (Fire Protection and Emergency Services Agreement dated July 20, 2020)

CLERK-TREASURER AND DEPARTMENT HEAD REPORTS

Police Chief Hamblen reported that he had spoken with Council Member Olson about traffic issues on Regency Drive raised by members of the neighborhood. Officers have targeted the area to monitor speeds. There was a crash last week when somebody went too fast around the curve. There were no injuries. The Traffic Commission may need to look at adjusting the speed limit. Discussion followed.

APPROVAL OF ACCOUNTS PAYABLE VOUCHERS

Council Member Martin moved to approve the Allowance of Accounts Payable Vouchers 47559 through 47820 totaling \$736,266.94. Council Member Olson seconded the motion. The motion carried 5-0.



The regular meeting of the Board of Public Works and Safety of the City of Angola, Indiana was called to order by Chair Richard M. Hickman at 6:31 p.m. at the Angola Training Center, 306 West Mill Street 1B. Members Richard M. Hickman and David A. Olson answered roll call. Member David B. Martin was absent. Clerk-Treasurer Debra A. Twitchell recorded the minutes.

Among those present were Chief of Police Stu Hamblen, City Attorney Kim Shoup, Assistant Fire Chief William Harter, Fire Captain Pete Decker, Firefighter Kevin Mory, Firefighter Paul Theil, Firefighter Terry Dowell, Economic Development and Planning Director Vivian Likes, Street Commissioner Doug Anderson, City Engineer Amanda Cope, Wastewater Superintendent Craig Williams, Water Superintendent Tom Selman, Human Resources Administrator Sue Essman, and Deputy Clerk Ryan Herbert.

Also, among those present were Ashlee Hoos of *The Herald Republican* and Colin Meadowcroft of WLKI.

APPROVAL OF MINUTES

Member Olson moved to approve the July 6, 2020 minutes. Member Hickman seconded the motion. On call of the vote, the motion carried 2-0.

ORDER OF BUSINESS

The Board was asked to consider a request by Greg Baird at 800 Butler Street to connect his property via driveway to Thomas Drive. City Engineer Cope explained that Mr. Baird plans to subdivide his land, build a new home on what would become an empty lot to the rear of the property, and sell the home at 800 Butler Street. Baird would like to place the driveway access to the new home at what is currently the dead end of Thomas Drive which currently ends 50' before arriving at Mr. Baird's property. Engineer Cope explained that the options would be for the City to extend Thomas Drive the additional 50' or grant Mr. Baird an easement 12' through the right-of-way to build his driveway to what is currently the end of Thomas Drive. Cope then stated that Street Commissioner Anderson expressed concerns with extending the street related to drainage, soil conditions, and snowplowing. Cope's recommendation was to grant Mr. Baird the easement. Economic Development and Planning Director Likes reported that Mr. Baird still needed to appear before the Pan Commission about subdividing the property. Board Member Olson expressed concerns with the property being further subdivided in the future to add more homes. Mr. Baird explained that his intent was to build a home for himself on the property and not divide further. Board Member Olson expressed concerns about extending the street because of snow removal and construction traffic. Discussion followed regarding construction access and quality of driveway to be installed. City Engineer Cope reiterated her recommendation to grant easement rather than extend the street. Discussion followed regarding legality of

an easement. City Attorney Shoup said he would have to investigate the legality of granting easement through the right-of-way. Member Olson moved to table the matter while legality of an easement is investigated. Member Hickman seconded the motion. On call of the vote, the motion carried 2-0.

The Board was then asked to accept the appointment of Christopher Greuter to the position of Probationary Firefighter to the Angola Fire Department. Human Resources Administrator Essman reported that the hiring process for Mr. Greuter started in May. He had passed his CPAT, aptitude, and physical and mental testing and had been accepted into the '77 pension fund. Member Olson moved to accept the appointment of Christopher Greuter to the position of Probationary Firefighter. Member Hickman seconded the motion. On call of the vote, the motion carried 2-0.

Member Olson then moved to accept the request for easement from Northern Indiana Public Service Company, LLC to install a guy wire on City property at Commons Park. Member Hickman seconded the motion. On call of the vote, the motion carried 2-0.

BE IT HEREBY ORDAINED by the Common Council of the City of Angola, Indiana that Title 10 Vehicles and Traffic, Chapter 10.25 Parking is being amended by the text of existing provisions in this style type, additions will appear in **this style type**, and deletions will appear in this style type:

Section 1. Section 10.25.160 Parking prohibited at certain times is amended to read as follows:

Where signs are erected giving notice thereof, it is unlawful for any persons to park any vehicle on any of the following streets and parts of streets in the city between the hours specified in this schedule:

AN ORDINANCE AMENDING THE CITY OF ANGOLA, INDIANA EMPLOYEE HANDBOOK, EMPLOYMENT POLICIES – EQUIPMENT, TOOLS AND MACHINES

BE IT HEREBY ORDAINED by the Common Council of the City of Angola, Indiana that the Employee Handbook is being amended by the text of existing provisions in this style type, additions will appear in **this style type**;

Section 1. Employment Policies – Equipment, Tools, Vehicles and Machines is amended to read:

Employees are responsible and held accountable for the proper use and care, operation and maintenance of all equipment, tools, vehicles and machines provided by the City. Employees who misuse, neglect or abuse equipment, tools, vehicles or machines are subject to disciplinary action.

Departments within the city maintain a number of *city-owned vehicles* provided for the sole purpose of conducting official city business. Following are guidelines that apply to the use of all city-owned vehicles:

- Proper use of safety belts is required.
- Holding or using a telecommunications device is prohibited while operating a
 moving motor vehicle. A telecommunications device may be used in conjunction
 with hands free or voice operated technology. A telecommunications device may
 be used or held to call 911 to report a bona fide emergency. For the purposes of
 this policy, the term telecommunications device includes a wireless telephone,
 personal digital assistant, pager or text messaging device.
- Operation of city-owned vehicles must be done in a safe, respectful, and courteous manner to ensure a positive representation of the City.
- Employees operating city-owned vehicles are responsible for notifying their supervisor of any damage, maintenance needs or safety concerns.
- Approval of all vehicle maintenance is the responsibility of the department head.
- Employees are required to possess a valid Driver's License or Commercial Driver's License (when required) and maintain an acceptable driving record during employment with the City when operating a vehicle is an essential function of their job. In addition, an employee whose license is suspended, revoked or expired must report this loss of driving privileges immediately to their department head.
- The City is subject to periodic driving record audits. If an employee, where driving is an essential function of the job, has not properly notified their department head of suspended, revoked or expired driving privileges and this is discovered during an audit, disciplinary action may result.
- Traffic fines and/or arrests while using a city-owned vehicle are the sole responsibility of the employee and may be subject to disciplinary action.

- Charges incurred for emergency repairs, road services or towing while traveling on city-related business are reimbursable when appropriate receipts are submitted, and approval is provided by your department head.
- In **the** case of a vehicle accident **crash**, follow standard procedures of calling the appropriate law enforcement agency and/or 911 in case of injury. All vehicle accidents **crashes** or injuries must be reported to your department head as soon as time allows. Your department head is responsible to **for** forward**ing** this **the police** report immediately to the Clerk-Treasurer's office for processing.
- In the case of a vehicle crash, the vehicle data recorder will be reviewed.

The following public safety positions are provided with a city-owned vehicle and are approved as *commute vehicles*:

Chief of Police Assistant Chief of Police* Police Sergeant* Police Detective*
Fire Chief Assistant Fire Chief Police Patrol Officer*

Commute vehicles are approved for travel to and from work and intended to assist with conducting city-related business. De minimis (minimal) personal use is permitted. Travel outside your department's jurisdiction for personal use is prohibited.

* Subject to Police Department Standard Operating Guidelines – Commute Vehicle Policy.

The following civilian positions are provided with a city-owned vehicle and are approved as *commute vehicles*:

City Engineer Building Commissioner Street Commissioner Park Superintendent Water Superintendent Wastewater Superintendent

Commute vehicles are approved for travel to and from work and intended to assist with conducting city-related business. De minimis (minimal) personal use is permitted. Civilian employees electing the option of a commute vehicle must live within Steuben County. If the employee elects not to use the city-owned vehicle as a commute vehicle, the employee must do so in writing to the Clerk-Treasurer.

Civilian use of a city-owned vehicle for commuting will be valued at \$1.50 each one-way commute. The Clerk-Treasurer's office is responsible for taxing commute vehicles. No adjustments on taxing from a prior pay period will be made if the required commute information is not provided at the time of payroll processing.

Internal controls have been established to comply with the IRS guidelines for the use of city-owned vehicles. Employees with commute vehicles and assigned a city-owned vehicle are required to complete the appropriate compliance documents.

Section 2. Effective date.

This ordinance shall become effective following passage and adoption by the Common Council and approval by the Mayor.

WHEREAS, the Community Crossing Matching Grant is an opportunity provided by the Indiana Legislature whereby communities are awarded moneys for infrastructure improvement projects;

WHEREAS, communities that are awarded grants are required to match the grant amount as a condition of the Community Crossing Matching Grant program;

WHEREAS, the City of Angola applied for and received a Community Crossing Matching Grant for \$772,242.74 to reconstruct three streets and maintenance for 21 streets;

WHEREAS, bids for these projects were received on May 18 and subsequently awarded in the amount of \$878,220.00 of which the City's 25% share is \$219,555.00 with a Grant 75% share of \$658,665.00;

WHEREAS, the Common Council, pursuant to HEA 1001-2016, established a Local Road and Bridge Matching Grant Fund for the receipt of said grant funds;

WHEREAS, the State Board of Accounts has directed units who received grant funds to transfer any cash match to the Local Road and Bridge Matching Grant Fund;

WHEREAS, on June 1, 2020, the Common Council approved the matching grant cash transfer of \$57,070.51 from the Motor Vehicle Highway Fund and \$162,484.49 from the Motor Vehicle Highway Restricted Fund;

WHEREAS, an additional \$30,092 is needed for the matching grant cash for these projects and is available in the Motor Vehicle Highway Restricted Fund;

THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF ANGOLA, INDIANA that for the expenses of the city government to meet the matching grants requirements, cash totaling \$30,092 is hereby transferred from the Motor Vehicle Highway Restricted Fund to the Local Road and Bridge Matching Grant Fund.

PUBLIC WORKS PROJECTS COSTING LESS THAN \$150,000

IC 36-1-12-4.9 states: (a) This section applies to a public work for the routine operation, routine repair, or routine maintenance of existing structures, buildings, or real property if the cost of the public work is estimated to be less than one hundred fifty thousand dollars (\$150,000). (b) The board may award a contract for public work described in subsection (a) in the manner provided in IC 5-22

We will not take audit exception to expenditures for projects under \$150,000 that maintain the existing condition of the asset or restore the asset to normal operating efficiency and which might qualify as routine operation, routine repair, or routine maintenance of existing structures, Included in our audit position could be buildings, or real property under IC 36-1-12-4.9. expenditures for the replacement and repair of elevators, flooring, ceiling, tile, bathroom fixtures, windows, sidewalks parking lots and roofs which would not be part of another public works Additionally, the costs associated with reconfiguring the interior of offices (additions/deletions of wiring for electrical outlets, lighting, data lines, and telephones, cubicle walls, etc.) and reconfiguring offices with movable walls which would not be part of another public works project, could be considered. Not included would be additions to the structure, reconfiguring offices with permanent walls, change of purpose of an area that involves substantial addition or removal of plumbing or gas lines (adding a kitchen area or bathroom), addition of elevator shafts, parking lots and other like changes to the interior or exterior that involve changes to the structural integrity of the building or improvements to real property, etc. or expenditures for which a determination has been made of the applicability of other provisions of the Public Works Law, IC 36-1-12-1 et seq. Our audit position is with the assumption a determination has been made by the governmental unit in a public meeting of the applicability of IC 36-1-12-4.9 to the proposed public works project.
