

**February 21, 2022**

The regular meeting of the Common Council of the City of Angola, Indiana was called to order at 7:00 p.m. at City Hall, 210 North Public Square with Mayor Richard M. Hickman presiding. Council Members Gary L. Crum, David A. Olson, David B. Martin, and Jerold D. McDermid answered roll call. Council Members Kathleen G. Armstrong was absent. Clerk-Treasurer Ryan P. Herbert recorded the minutes.

Among those present were City Attorney Kim Shoup, Chief of Police Darrin Taylor, City Engineer Amanda Cope, Wastewater Superintendent Jeff Gaff, Fire Chief T.R. Hagerty, and Accounts Payable Clerk Stephanie Dean.

Also, among those present was Austin Budreau, and Beth Swary of *The Herald Republican*.

#### REMARKS BY THE MAYOR

Mayor Hickman gave accolades to Street and Wastewater Departments on work during the winter storms. Great work has also been done on the stormwater system by current and past Mayors, Councils, and City Engineers to handle these large amounts of water.

#### APPROVAL OF THE MINUTES

Council Member Olson moved to approve the February 7, 2022 minutes. Council Member McDermid seconded the motion. The motion carried 4-0.

#### UNFINISHED BUSINESS

Ordinance No. 1692-2022, AN ORDINANCE REESTABLISHING THE CUMULATIVE CAPITAL DEVELOPMENT FUND UNDER INDIANA CODE 36-9-15.5, was read by title and presented to Council on second reading. Council Member Martin moved to approve. Council Member Crum seconded the motion. The motion carried 4-0.

Ordinance No. 1693-2022, AN ORDINANCE REESTABLISHING THE PARK AND RECREATION CUMULATIVE BUILDING FUND UNDER INDIANA CODE 36-10-3-21, was read by title and presented to Council on second reading. Council Member Olson moved to approve. Council Member Crum seconded the motion. The motion carried 4-0.

#### NEW BUSINESS

Resolution No. 2022-816. A RESOLUTION FOR THE TRANSFER OF APPROPRIATIONS FOR THE CITY OF ANGOLA FOR THE GENERAL FUND AND FORWARDED TO THE COMMON COUNCIL FOR THEIR ACTION AND PASSAGE PURSUANT 6-1.1-18.6., was read by title and presented to Council for

approval. Council Member Martin moved to approve. Council Member McDermid seconded the motion. The motion to approve carried 4-0.

Resolution No. 2022-817. CITY OF ANGOLA, INDIANA RESOLUTION OPPOSING LEGISLATION REGARDING THE BUSINESS PERSONAL PROPERTY TAX, was read by title and presented to Council for approval. Council Member Olson moved to approve. Discussion followed. Council Member Martin seconded the motion. The motion to approve carried 4-0.

Council Member Olson moved to approve the Task Order No. 2022-01 with Commonwealth Engineers, INC. for Angola Focused Use Attainability Analysis not to exceed the amount of \$10,000. Council Member Crum seconded the motion. The motion to approve carried 4-0.

Council Member McDermid moved to approve the Façade Grant agreement with Austin S. Budreau/ ASB Real Estate LLC for property located at 400 W Maumee St. in the amount of \$5,000. Discussion followed. Council Member Olson seconded the motion. The motion carried 4-0.

The Clerk-Treasurer’s Depository Statement and Cash Reconciliation for the month ending January 2022 was presented for Council information.

APPROVAL OF ACCOUNTS PAYABLE VOUCHERS


