The regular meeting of the Common Council of the City of Angola, Indiana was called to order at 7:17 p.m. at City Hall, 210 North Public Square with Mayor Richard M. Hickman presiding. Council Members Gary L. Crum, David A. Olson, Kathleen G. Armstrong, David B. Martin, and Jerold D. McDermid answered roll. No Council Member was absent. Clerk-Treasurer Ryan P. Herbert recorded the minutes.

Among those present were City Attorney Kim Shoup, Chief of Police Ken Whitmire, Fire Chief Doug Call, Planning and Economic Development Director Jennifer Barclay, City Engineer Amanda Cope, Water Superintendent Tom Selman, Park Superintendent Matt Hanna, Human Resources Director Sue Essman, Street Superintendent Chad Ritter, and Engineering Assistant Nick Gerber.

#### APPROVAL OF THE MINUTES

Council Member Martin moved to approve the August 15 and 29, 2022 minutes. Council Member Armstrong seconded the motion. The motion carried 5-0.

#### UNFINISHED BUSINESS

Ordinance No. 1709-2022. AN ORDINANCE FIXING COMPENSATION OF ELECTED OFFICIALS OF THE CITY OF ANGOLA, INDIANA FOR THE YEAR 2023, was read by title and presented to Council on third and final reading. Council Member Martin moved to approve. Council Member McDermid seconded the motion. The motion to approve carried 5-0.

Ordinance No. 17010-2022. AN ORDINANCE AMENDING THE ANGOLA MUNICIPAL CODE, TITLE 10 VEHICLES AND TRAFFIC, CHAPTER 10.25 PARKING, was read by title and presented to Council on third and final reading. Council Member McDermid moved to approve. Council Member Martin seconded the motion. The motion to approve carried 4-1. Member Olson dissented

#### NEW BUSINESS

Ordinance No. 1711-2022. AN ORDINANCE AMENDING THE CITY OF ANGOLA, INDIANA EMPLOYEE HANDBOOK, PAYROLL STANDARDS- CALL-IN PAY AND EMPLOYEE BENEFITS- LEAVE PROGRAMS, was read by title and presented to Council on first reading. Council Member Martin moved to approve. Council Member Olson seconded the motion. The motion carried 5-0

Mayor Hickman presented the 2023 Budget. A budget workshop was scheduled for Wednesday September 14 at 10:00 a.m. at City Hall.

Clerk-Treasurer Herbert presented the 2022 Budget Management Report which is presented annually in conjunction with the budget presentation. The report is historical, current, and projected revenues, expenditures, and cash balances for governmental funds over a period of eight years and may be used as a reference tool during the annual budget process. The report complies information on operating, capital, and pension funds and includes the City's 2022 amended budget and 2023 proposed budget.

CLERK-TREASURER AND DEPARTMENT HEAD REPORTS

Economic Development & Planning Director Barclay reported that there had been eleven sculptures submitted for consideration for downtown. Improvements would be taking place to the alley at Caleo Café. Plan Commission had approved a primary plat for storage units in the northern part of the ETJ. The West Commons project has closed on the property and planned to demo the University Inn by the end of the year. Also, the Cruise to the Monument is coming up on September 21<sup>st</sup>.


Fire Chief Call announced the department would be hosting a push in ceremony for the new fire engine on Monday September 12<sup>th</sup> at 6:00


APPROVAL OF ACCOUNTS PAYABLE VOUCHERS
